### What is an ERCP?

**Emergency Response and Contingency Plan** 

A who, what, where, when why of responding to emergencies and abnormalities that may affect your water system.



### Why have a plan?

#### 1. You must.

Drinking Water Protection Act Section 10

#### 2. To be prepared.

- Continuity of water service
- Protect public health of users

### What is required in the plan?

#### Outlined in the Drinking Water Protection Regulation:

- Critical contact information
- Identify individuals to contact in various emergencies
- Mitigation steps
- Communication strategy to users

### What is required in the plan?

Possible emergencies or abnormalities to consider:

#### **Biological Contamination**

- Presence of total coliforms or E. coli, flooding

#### **Chemical Contamination**

Accident/spill, shift in water quality, treatment system failure (i.e. overdosing chemical additives)

#### Infrastructure Failure

- Treatment equipment breakdown, water main break

#### **Loss of Source**

- Pump failure, earthquake, drought, wildfire



### You have a plan, what next?

- Train staff
- Have a summary available for users
- Review it annually
- TEST IT
