## **BYLAW NO. 1540**

## A BYLAW TO ESTABLISH THE ELECTORAL AREA 'G' OFFICIAL COMMUNITY PLAN

#### WHEREAS:

- A. Under section 876 of the *Local Government Act* the Board may adopt an Official Community Plan by bylaw.
- B. The Board of the Regional District has:
  - (a) Considered the plan in conjunction with its most recent capital expenditure program under section 882 of the *Local Government Act* and its Liquid Waste Management Plan and the Regional Growth Strategy and is assured of consistency between them; and
  - (b) referred the plan to the Provincial Agricultural Land Commission, City of Parksville, and the Town of Qualicum Beach for comment; where provided, and the Board has received those comments.
- C. A Public Hearing has been held on the plan on the 18<sup>th</sup> day of March 2008, after the plan had been referred to the Provincial Agricultural Land Commission, the City of Parksville, and the Town of Qualicum Beach.

**NOW, THEREFORE**, the Board of the Regional District of Nanaimo in open meeting assembled HEREBY ENACTS AS FOLLOWS

## 1. <u>Title</u>

This Bylaw may be cited as "Regional District of Nanaimo Electoral Area 'G' Official Community Plan Bylaw No. 1540, 2008."

## 2. Application

This Bylaw is applicable to Electoral Area 'G' of the Regional District of Nanaimo as shown outlined on Map No. 1 of Schedule 'A' of this Bylaw.

## 3. Public Consultation Strategy

This Bylaw is being considered pursuant to an approved public consultation strategy in accordance with Section 879 of the *Local Government Act*.

## 4. Official Community Plan

The official community plan is comprised of Schedule 'A' and Map Nos. 1 through 10 (inclusive), which are attached to and form an integral part of the Bylaw.
