Questions and Answers:

Q1) Who will be evaluating the proposals?

- A1) Operations Superintendent, Chief Operator (Greater Nanaimo Pollution Control Centre), Chief Operator (French Creek Pollution Control Centre), and Engineering Technologist Wastewater Services
- Q2) Who is responsible for holding RDN's electrical permits with Technical Safety BC?
- A2) The RDN holds its own electrical permits for the Southern Communities (Greater Nanaimo Pollution Control Centre and Duke Point).

The electrical maintenance contractor would be responsible for holding the electrical operating permits for the Northern Communities (French Creek Pollution Control Centre and Nanoose). The electrical operating permits are for Class B sites.

- Q3) Does RDN Wastewater Services have any Class A facilities licensed by Technical Safety BC?
- A3) The Departure Bay pump station facility is considered a Class A site by Technical Safety BC. The RDN has obtained a variance for this facility.
