Questions and Answers:

Q1) Could you please confirm the dimensions and requirements for the Roll Off & Roll On Bins

A1) Bins must be 7 foot (wide) by 10 foot (long) by at least 55 inches (4.6 ft) (tall). Bins must be compatible with the loading locations at GNPCC and FCPCC.

Bins must have a lid that can be closed during transport. The lids must be able to be opened at the loading facility to allow bins to be filled while the bins are placed. The contractor must open this lid after delivering a new bin and close and secure the bin lid prior to transport.

The RDN would prefer that the proposed bin lids at GNPCC be similar in function to the FCPCC bin lids (see picture below from Request for Quotations Appendix A – Figure 1).





- Q2) It will be difficult to provide a bin cover immediately for the GNPCC Screenings service. Would the RDN accept an interim cover for several months?
- A2) Yes, the RDN would accept an interim cover for up to 2 months provided that this cover completely prevents spills during transport and provides for effective odour control.
- Q3) Where would access be to the screenings building and grit building after is constructed (estimated to be around August)?
- A3) Access will be via the road by the fence at GNPCC by Hammond Bay Road north of the digester.
- Q4) When will screenings removal start at GNPCC?
- A4) Screenings removal at GNPCC is estimated to commence in mid-May. The exact start date is uncertain due to the GNPCC secondary upgrade construction.



Q5) Please confirm the width between the bin rails in the Screenings building at GNPCC.

A5) The width between the railings is 7 foot 6 inches by 10 foot (see picture below).
