Appendix 1 Item No. 2.5 Common Excavation, storage, and re-use of native materials for embankment fill

Common excavation, storage and re-use of native materials for embankment fill shall include all labour and materials required to process, place, and compact native materials for embankment fill in accordance with the Contract Drawings and specifications.

Measurement shall be for the volume placed after compaction. Payment shall be made at the tendered price and include all required material removal, storage, handling, disposal, and any required surface reinstatement.

8.2 Special Provisions

8.2.2 Additional Instructions from FLNRORD

All trees within the MOTI ROW must be felled by hand; no trees may be pushed over. All merchantable timbers to be limbed, cut to a 10cm top, and decked for the woodlot licensee to collect using a self-loading truck. All other wood will be disposed of as per OLTC L51395.

3. Question: Are all stripping to be disposed off-site?

Answer: Yes. Stripping of unsuitable material shall be as per payment item 2.3.

4. Question: Can stripping be spread on-site rather than off-site disposal?

Answer: No, not at this time. If during construction, the soil is deemed suitable for re-use, then, it may be approved as import fill material. Otherwise, please price the project as removal.

5. Is there a payment item for on-site cut to fill?

Answer: Please refer to the updated Schedule of Quantities – Item 2.5.

6. Is the contractor responsible for assessing and removing trees within the clearing boundary safely?

Answer: Yes. Contractor is responsible for falling and removing the trees safely. Falling must be done by licensed tree faller(s). If the contractor believes that there are danger trees that may require additional considerations and/or permits, they should provide for those within the tender.

7. What is the existing topography and proposed grade for gravel area (well development area)?

Answer: No survey has been completed for the Private Land. However, the contractor should view the area to have an understanding of the topography. The area needs to be graded to accommodate a drilling rig.

8. Looking for a clarification on the (2) tenures and the area volume attributed to each. The lay down area – is private land? Is the lineal area 20m x 100m? Is the square meters 2,000 sq meters? In the Schedule of Quantities, the clearing and grubbing area indicated is 2550 sq m.. is this the correct area or is the area transposed with the area sq m for the MOTI ROW?
