

MEETING DETAILS

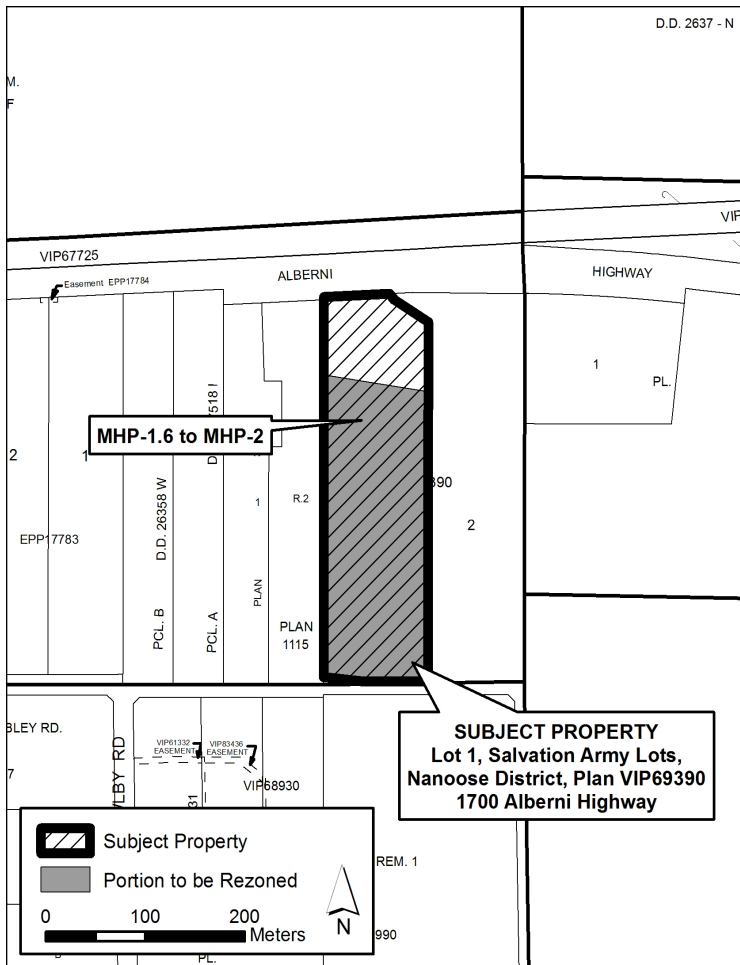
Monday, June 28, 2021 at 6 p.m.

Pursuant to Sections 464, 465 and 466 of the *Local Government Act*, the Regional District of Nanaimo advises of a Public Hearing regarding “Regional District of Nanaimo Electoral Area ‘F’ Zoning and Subdivision Amendment Bylaw No. 1285.32, 2021” (Bylaw 1285.32).

In consideration of current restrictions on in-person gatherings due to the COVID-19 pandemic, this Public Hearing is convened by virtual means as authorized by Ministerial Order No. M192, “Local Government Meetings and Bylaw Process (COVID-19) Order No. 3”.

PURPOSE OF THE BYLAW

The purpose of Bylaw 1285.32 is to amend “Regional District of Nanaimo Electoral Area ‘F’ Zoning and Subdivision Bylaw No. 1285, 2002” to rezone a portion of the subject property from Manufactured Home Park 1.6 (MHP-1.6) to Manufactured Home Park 2 (MHP-2) to allow up to an additional twenty-two manufactured homes.



HAVE YOUR SAY

All persons who consider their interest in property to be affected by the proposed bylaw shall be afforded an opportunity to be heard virtually or by written submission at the Public Hearing. The video feed of the Public Hearing will be live streamed. Anyone who wishes to be heard at the hearing can do so by telephone only. The instructions for how to access the live video feed and speak at the Public Hearing are as follows:
