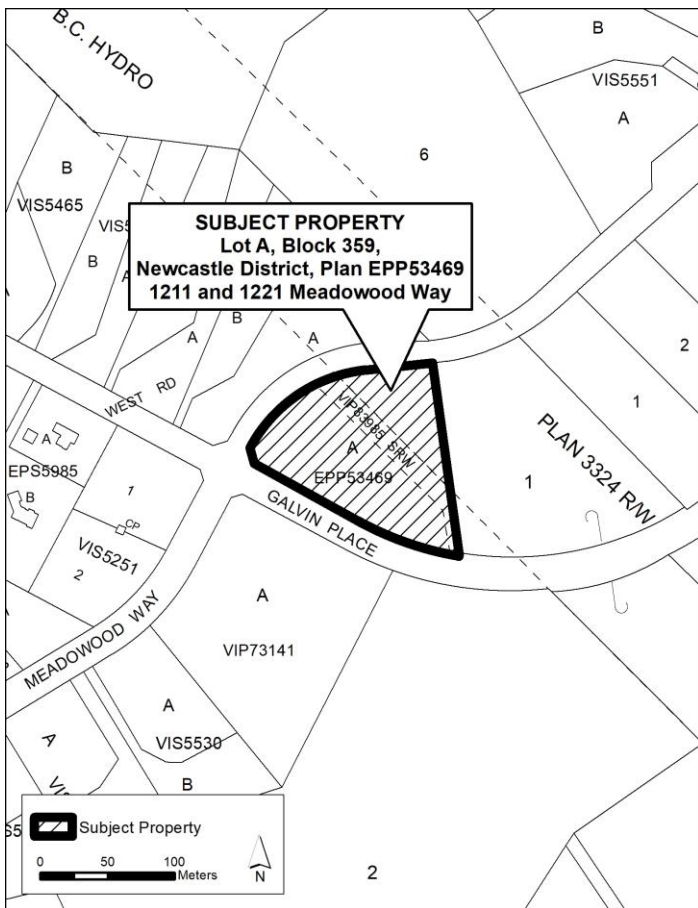

The RDN advises of a Public Hearing regarding the proposed retail sale of non-medical cannabis (NMC) within a stand-alone building at 1211 and 1221 Meadowood Way.

PURPOSE OF THE HEARING

The purpose of the hearing is to provide an opportunity for the public to hear the application details and to provide comment. The RDN Board will consider all submissions and comments and possible impacts of a Non-Medical Cannabis (NMC) retail store on the community. With this, the Board will provide a recommendation to the Liquor and Cannabis Regulation Branch (LCRB) to approve or deny the proposed NMC retail store licence for the property shown in the Location Map below.
