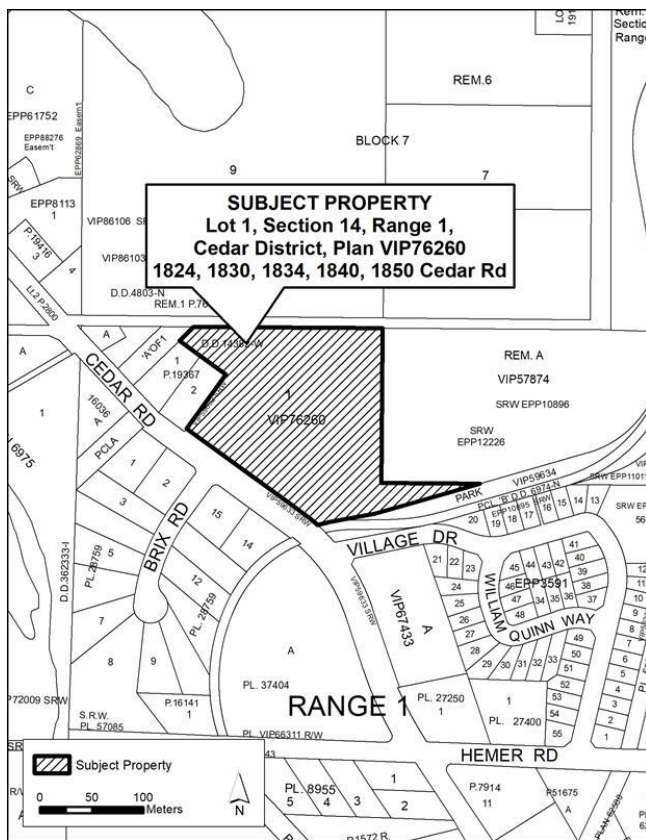

Board Chambers – Webstreamed

The Regional District of Nanaimo (RDN) advises of a Public Meeting regarding the proposed retail sale of Non-Medical Cannabis (NMC) at 1824 Cedar Road (To be held in conjunction with Public Meeting for NMC Application PL2021-143 at 2414 Island Highway East).

PURPOSE OF THE MEETING

The purpose of the meeting is to provide an opportunity for the public to hear the application details and to provide comment. The RDN Board will consider all submissions, comments and possible impacts of a NMC retail store on the community. With this, the Board will provide a recommendation to the Liquor and Cannabis Regulation Branch (LCRB) to approve or deny the proposed NMC retail store licence for the property shown in the Location Map below.



HAVE YOUR SAY

All persons who consider their interest in property to be affected by the proposed licence shall be afforded an opportunity to be heard electronically or by written submission at the Public Meeting. The Public Meeting will be live streamed.
