This addendum shall be read in conjunction with and considered as an integral part of the Request for Tender. Revisions supersede the information contained in the original Tender or previously issued Addendum. No consideration will be allowed for any extras due to any Vendor not being familiar with the contents of this Addendum. All other terms and conditions remain the same.

A. Questions & Answers

- Q1. The new roof framing drawings seem to indicate that columns TC1 & TC2 are engineered wood products. The structural drawings include these columns as DFIR #1. If these columns are now engineered wood products, then could you please confirm the specification?
- **A1.** These columns are DFIR #1.
- Q2. It appears that each end of the SPF rafters requires a tooled pocket shaped into the supporting glulam beams. Providing this joinery for each and every rafter will have a significant impact on the tender price. Please consider simplifying these joints if possible. If this joinery is required, then please confirm that all bidders shall include this joinery in their bid prices, and bidders shouldn't assume that any other joinery will be approved by the engineer.
- **A2**. There is an option to use face mount hangers here (Simpson Strongtie U410X to suit slope and skew). See attached revised Bid Form. Contractors to provide provisional pricing to delete joinery details and use face mount hangers instead.
- Q3. Drawing A1.02 indicates that the low slope portion of the roof requires a minimum 2% slope to the custom galvanized gutter. Please confirm how the 2% slope should be achieved.
- A3. Lower than 2% slope may be acceptable if a roof warranty is provided to the owner's satisfaction. To avoid shimming the structural plywood, slope can be built up with the torch-on, or other method on top of the plywood. Please also note that the galvanized 5" half round gutter is not intended to be custom.

- **Q4**. Please provide clarity regarding the cedar T&G deck seating:
 - Please clarify specification for cast in place anchors not shown on structural.
 - Can we orientate the deck boards lengthwise, reducing the number of anchors required? If so, please clarify spacing of CIP anchors.
 - If possible, provide further detail for T&G board installation.
- A4. Anchors for the bench detail can be cast in place as shown, or exterior concrete screws to a min depth of 75mm. Contractor to provide submittal of hardware connection for review and approval, and coordinate w/ rebar locations.
 - Bench boards can be rotated to run lengthwise (N-S on the east bench and E-W on the north bench). Note that the boards do not change direction when they turn the SE corner, so some boards would still run the short direction. If boards are rotated lengthwise, contractor to add skateboard deterrent brackets at 4' O.C along inside edges of boards.
 - -The above information will be added to a revised bench detail for IFC.

B. Reminder
