



# Pre-approval Application: 2021 Wellhead Upgrades Rebate

The RDN is offering rebates of up to \$650 to help residents upgrade their private domestic wellhead. In 2005 the Province of BC introduced new best practices for wellhead construction to better protect ground-water quality. Rebates to bring wellheads up to current standards are available until December 15, 2021 or until funds are exhausted. Apply for pre-approval to “reserve” funds for eligible work for up to 90 days. If you qualify for the rebate, an approval letter will be sent to you.
