

Pre-approval Application: Irrigation Upgrades & Soil Improvements

The RDN is offering rebates of up to \$675 region-wide for residents to improve the water efficiency of their existing landscape. This program is designed as an incentive to reduce water waste in two ways: irrigation efficiency and soil quality. Rebates are available for work completed between January 1 and December 15, 2022. Apply for pre-approval to "reserve" funds for eligible work for up to 90 days. If you qualify for the rebate, an approval letter will be sent to you.
