### **REGIONAL DISTRICT OF NANAIMO PROPERTY TAXES**

You have received your 2023 property tax notice from your municipality. Municipalities collect taxes for schools, roads, policing, hospital and regional district services among other taxes. The Regional District of Nanaimo (RDN) receives a payment from municipalities within the RDN in August each year. This payment goes directly toward the RDN services provided in your area.

The Nanaimo Regional Hospital District (NRHD) provides capital funding for Nanaimo Regional General Hospital, Dufferin Place, Eagle Park Health Care Facility, Trillium Lodge and Oceanside Health Centre. The Province shares capital funding costs with NRHD on a 60/40 basis with the NRHD's portion being 40 per cent. Island Health pools funding from the Province, NRHD and other sources to maintain, improve and build health care facilities on Vancouver Island.

A budget of \$29.5 million was adopted for 2023 including \$4 million for minor capital equipment and projects, \$740,000 for administration and professional fees and \$6.36 million for debt servicing for major capital projects. The budget includes capital projects planned or underway including a new Intensive Care Unit, SPECT CT Scanner, Rehab Wing Chiller, Chiller System Optimization, Fluoro X-Ray Machine Replacement, a new High Acuity Unit and a Meal Assembly and Delivery System.

Potential future projects include a new patient tower, cancer centre and cardiac catheterization lab, as well as a new long-term care facility. A tax levy of approximately \$35.18 per \$100,000 of assessed property value in 2023 is included in the budget as well as a contribution of \$18.4 million into reserves, an increase of \$3.92 per \$100,000 from the previous year. The goal is to accumulate reserves to reduce reliance on debt and prepare the NRHD to meet its partnership funding obligations for large priority projects that are urgently required in the region.




